# **Competition Director**

Mike Godfrey reported

That the RCDs are discussing possible changes to top 15 awards for speed events and non-speed events; they had discussion about use of time trials; they discussed rule book changes.

The 2022-2023 rule book is in effect. The changes to rule book will become effective for 2024-2025. There was a request through rule change 13 to not allow optional slaloms- request did not pass; Rule change 8 passed- requires certain information must be on each event flyer-see official list on the NCCC website

Paul Clawson asked about promoting NCCC and racing to younger generation. After much discussion Howard Curtis stated that someone would need to write up a rule change request and present it to the RCDs for consideration. The consensus of the group is that it is also the responsibility of the individual clubs to do a better job promoting.

Mike reported that Electric Vehicles will not be allowed at races. There is a safety concern relating to fires that needs to be addressed before they will be allowed.

### **Membership Director Report-**

Nick Heffelmire reported on FCOA membership. Shannon Davis-FCOA Director reported that he will send RMDs membership information, but he will not provide information to any other individuals. This is for the safety of the children involved in the program.

NCCC has 18,694 members; 238 clubs; Indiana has 1,373 members in 17 Clubs and Fort Wayne is the largest with 265 members

# November 25<sup>th</sup> is the last day for renewals and renewals need to be to Nick by this date.

Membership cards will go out in the mail in January, but members will also receive an email version. Discussion broke out about membership benefits and it was reminded that the insurance is a benefit to clubs- for example if a club treasurer take the club's money-it is covered by NCCC insurance.

Nick reported there were 41 Corvette deliveries at the Museum for which Indiana received 1 year NCCC memberships. Nick also reported that some sponsor dealerships are also offering a 1 year membership to NCCC when their customers purchase a new corvette.

Nick reminded Governors that if they are going to have dinner after an event, to please put it on the event flyer, otherwise it is not part of the event and not covered by NCCC insurance.

Mike Godfrey asked if there were any clubs lost from NCCC this year. Nick reported that he is not aware of any Indiana clubs that have left NCCC.

Becky Graves Thanked the veterans in the room for their service

Jerry reported that Penske Chevrolet is their sponsor, and they give out free membership to the club each year for new corvettes that are purchased through them. May want to ask your sponsors.

Jim Bartuska reported that Indiana Corvette Club has 5 or 6 charter members of the National Council. One of those is Van Gates who is the owner of Gates Chevrolet in South Bend. He is now 98 years old and they are now opening a new dealership in South Bend.

Mike discussed worker shortages at events. There was some additional discussion on getting younger people involved in the clubs and the need to have drivers serve as workers. Reminder that workers only need to work three weekends to earn a region jacket.
